AIR CARRIER GROUPINGS

This Accounting and Reporting Directive updates the reporting groups for filing the Form 41 report during calendar year 2015. From our review, we updated the carrier groupings as follows:

**AIR CARRIER**


**NEW REPORTING GROUP**

Kalitta Air	Group III to Group II
Lynden Air Cargo	Group II to Group I - \$20 million to \$100 million
Polar Air Cargo	Group II to Group III
Vision	Group II to Group I - \$20 million to \$100 million
World Atlantic	Group I – Under \$20 million to Group I - \$20 million to \$100 million

Carriers are grouped according to the operating revenue boundaries contained in Section 04 of Part 241. The current reporting levels are:

Group III	Over \$1 billion
Group II	Over \$100 million to \$1 billion
Group I	\$100 million and under
Subgroups:	
	Group I - \$20 million to \$100 million
	Group I - Under \$20 million
